A Strong Loonie

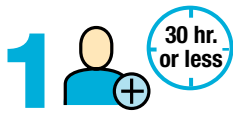

Only private businesses, including sole proprietors, general and limited partnerships and corporations, and non-profit organizations are eligible.



Are you applying to hire a current employee into a new or vacant position?

Current employees within your organization are not eligible.

Has the new hire previously worked for your organization within the past 90 days?

Previous employees within the past 90 days are not eligible.

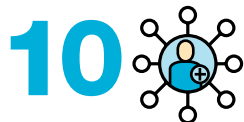
