### Tax Changes for 2021

- The federal government has introduced the Canada Training Benefit.
   Workers are now eligible to receive up to \$250 annually as a tax credit for training.
- The maximum Child Tax Benefit a parent can receive in 2021 is now \$6,765 for children under 6. This is an increase of \$120 from 2020.
- Canada's Pension Plan contributions 2021 Employee and employer contribution rates will be increase by 5.45%, up from 5.25% in 2020.

### Alberta Re-Opening for Canada Day

The big news right now is the reopening of the province on July 1. Premier Jason Kenney announced last week that Alberta has reached Stage 3.

While the City of Calgary's mandatory mask bylaw will remain in place until at least July 5, Edmonton, Okotoks, and Banff have announced they will follow the province's timeline and remove their rules on Canada Day.
