Taxpayer relief for Work from Home

The government this week confirmed that employees who are working from home can continue to use the temporary flat rate method, introduced for the 2020 tax year, to calculate home office expense deductions.

The government announced it would be increasing the maximum claim to \$500 (from \$400), and these rules will apply for the 2021 and 2022 tax years.

Multiple people working from the same home can each make a claim. All days worked from home, either full time or part time, count. Vacation days, sick days and days on a leave of absence do not.

PROGRAMS AND GRANT UPDATES

Restrictions Exemption Program Implementation Grant

Private passenger vehicle operators, chartered to transport patrons or attendees by an in-scope business, entity or event, <u>may apply for a grant to implement the Restrictions Exemption Program</u>. These vehicles may include party buses, tour buses, pedal pubs and private charters.

HASCAP Extended till Mar 31, 2022

Businesses heavily impacted by COVID-19 can access guaranteed, low-interest loans of \$25,000 to \$1 million to cover operational cash flow needs.

Tax Updates for 2022

- Federal income tax brackets have been indexed to inflation using the 2.4% rate.
- The Canada Pension Plan (CPP) rate is 5.7%
- Employment insurance premiums have a contribution rate for employees of 1.58%
- The 2022 tax-free savings account (TFSA) contribution limit will remain at \$6,000
- The registered retirement savings plan (RRSP) dollar limit for 2022 is \$29,210

Lockdown Program & Worker Lockdown Benefit

The Government is temporarily expanding access to the following programs. These regulations will apply from December 19, 2021, to February 12, 2022

- **Local Lockdown Program** to include employers subject to capacity-limiting restrictions of 50 per cent or more; and reduce the current-month revenue decline threshold requirement to 25 per cent. Eligible employers will receive wage and rent subsidies from 25 per cent up to a maximum of 75 per cent, depending on their degree of revenue loss.
- Canada Worker Lockdown Benefit to include workers in regions where provincial or territorial governments have introduced capacity-limiting restrictions of 50 per cent or more.
